What is Ukraine's import tariff schedule?

According to Article VII of the Law of Ukraine on Foreign Economic Activity, Ukraine's import tariff schedule includes three rates of import duties: Full - The full rate of import duties can be from two to 10 times higher than the Most Favored Nation rate.
