What is the tariff rate in the Philippines?

The Philippines bound 67.6% of its tariff lines in the World Trade Organization (WTO), with a simple average final bound tariff rate of 24.9%. As a rule, imported manufactured goods competing with locally produced goods face higher tariffs than those without local competition.

Why is the US imposing a 19% tariff on Philippine exports?

The imposition of a 19% U.S. tariff on Philippine exports is a significant setback with the potential to disrupt trade flows and economic stability.
