China export restrictions govern the export of goods, technologies, and services from the mainland through a multi-layered framework led by the Export Control Law, the Foreign Trade Law, MOFCOM licensing, and GACC customs supervision.

What is China's Export Control Law?

China's Export Control Law sets the overarching rules for controlled items--dual-use goods, military items, nuclear materials, related technologies, and services. It authorizes bans or license requirements for specific destinations, organizations, and individuals, and it explicitly covers technical documents and data.

The basic customs duty of 25% on imported solar cells and 40% on imported modules is expected to increase project costs.
