
Tariffs on export of solar modules

What tariffs are imposed on Chinese solar cells & modules?

The U.S. had imposed several trade barriers against Chinese solar cell and module imports. In addition to the original 25% tariff under the Section 301, there are anti-dumping and countervailing duties (AD/CVD) that have been imposed since 2012 as well as the Section 201 tariffs targeting cells and modules from all countries.

How do tariffs affect the US solar industry?

As a result, tariffs can still have a substantial impact on the US solar industry, especially those targeting these four Southeast Asian countries. A combined 80% of US solar PV module imports are from Cambodia, Malaysia, Thailand, and Vietnam, and a little less than 60% of US PV cell imports are from these nations.

Will solar imports come with new tariffs?

The ITC agreed with the petitioners, and solar imports from Southeast Asia will come with new tariffs on top of any country-wide tariffs initiated by the Trump Administration already.
