Are Kazakhstan tax residents taxed on their income?

YesKazakhstan tax residents are taxed on their worldwide income, while tax non-residents are taxed only on their income derived from sources in Kazakhstan. A flat flat personal income tax rate of 10% (20% in some cases) applies to most types of personal income; the 5% rate applies only to dividends received in Kazakhstan.

Does Kazakhstan impose VAT on e-commerce companies in 2022?

From 2022, Kazakhstan introduced a VAT obligation on foreign internet e-commerce companies that sell goods and provide electronic services with a registration procedure but may not have to provide tax reporting.

Is VAT a tax in Kazakhstan?

Value Added Tax (VAT) is the principal indirect taxin the Republic of Kazakhstan. VAT is a tax on consumer expenditure and is collected on business transactions and imports. Is there a registration limit for the tax? Yes. Shall the annual turnover of transactions in Kazakhstan exceed a certain limit it is required to register as a VAT payer.

What is the corporate income tax rate in Kazakhstan?

The corporate income tax rate is 20% and is assessed on a calendar year basis. Resident companies in Kazakhstan tax worldwide profits, while non-resident companies operating through a permanent establishment (PE) in Kazakhstan are subject to Kazakhstan income tax only on profits attributable to that PE.

The tax rate is set at KZT 2 per kilowatt-hour of electrical energy consumed depending on the amount of electricity consumed. The tax period is a calendar quarter.
