## Will the rooftop solar panels be lost later

Can rooftop solar save you money?

In many markets, households can still generate savings by installing rooftop solar. Including all costs of installing a solar rooftop, the electricity generated over its lifetime--the unsubsidized levelized cost of energy (LCOE) 1 --is still cheaper than comparable grid electricity in many markets.

What happens to solar panels after 25 years?

After 25 years, your solar panels will likely still generate electricity, but at a lower efficiency. At this stage, you have three main options: keep them in service if they're still performing well; upgrade to newer, more efficient models; or recycle them through an approved solar panel recycling scheme.

Do solar panels degrade over time?

All solar panels degrade over time as exposure to the elements slowly reduces their ability to convert sunlight into electricity. The rate of degradation varies by brand and quality, but it's usually around 0.5% efficiency loss per year.

Should I keep my solar system after it's paid off?

Increasing power production: While keeping your existing system after it's paid off allows you to generate free solar energy, you might want to increase the amount of solar power your system generates with new, higher efficiency panels occupying the same roof space.
